Hi [REDACTED],

As discussed, the information provide to the BBC by the individual is either misrepresentative or false - this individual is also known to Welsh Government and has a specific agenda.

We would prefer to distance coal tip safety from this, where possible. It is a complex issue and is in fact driven by a multitude of other factors.

It would also be worth asking Education if they have anything more specific re the school.

Generic Lines:

- The recent round of winter inspections of category C and D tips concluded in February and no major concerns were raised.
- The Coal Authority have been asked to inspect category C coal tips once a year and category D twice a year and in 2023 the Coal Authority began a process of inspecting all Category B tips. This work helps to identify any maintenance works needed.
- It is worth noting that the category of a tip is based on several factors, including the closeness of a tip to local communities, houses or major infrastructure. A tip with Category C or D does not mean it is unsafe, but it may be larger or more likely to be closer to communities or major infrastructure.
- The Welsh Government has made available £44.4 million in capital funding for coal tip maintenance over financial years 2022 to 23, 2023 to 24 and 2024 to 25.

We've had the below query from BBC on Godre'r Graig primary school closing due to concerns of a landslide from a quarry behind the school.

Demolition work on the school begins Monday, are you able to provide some lines for a response? Would be good to have something in case of further queries over

the weekend for duty officers.

We've had the below from the journalist:

Campaigners who wish to save the school are saying the tip that's been registered on the Coal Tip Map is a different one to which NPT are claiming is a danger.

"The small quarry at the top is included on the new national **Coal Tip Map** published in Nov 23 but that's a fraction of the site Neath Port Talbot Council /Earth Science Partnership claim might be the tip boundaries. It's also a sandstone quarry, not a coal spoil tip.

"I had a couple of meetings with Sam Deely, Head of Spoil Tips, Welsh Government in the summer.

"He gave me the June 2023 WG Inspection which clearly states the slope studied by ESP is outside the tip boundary and the tip is an old sandstone quarry.

This inspection only happened after I met Sam and it appears the WG have had some difficulty with missing paperwork from NPT. It's a real mess.

"The authority has claimed funding from the Coal Tip Safety Grant for this and there are doubts if that is allowed. I believe a fudge is being done to justify that funding by including the small quarry and calling it a coal tip, but that now casts massive questions, as none of the ground investigations have actually been done on any registered tip and none of ESP work can be accurate."

I'm working on a piece about Godre'r Graig primary school. Neath Port Talbot council are planning to start demolition work on the school on Monday after years of concern about a medium risk of landslide behind the school because of a quarry tip.

Campaigners who wish to save the school are saying the tip that's been registered on the Coal Tip Map is a different one to which NPT are claiming is a danger.

I've had this information:

"The small quarry at the top is included on the new national **Coal Tip Map** published in Nov 23 but that's a fraction of the
