Subject	Sustainable Communities for Learning Programme - Neath Port Talbot – Programme Variation		
100 word summary	You are asked to approve the recommendations of the Education Investment Panel regarding Sustainable Communities for Learning Band B, programme variation for Neath Port Talbot County Borough Council.		
Timing	Project funding is time dependent; we would request a decision at the earliest opportunity.		
Recommendation	The Minister is asked to approve the recommendations of the Education Investment Panel regarding Neath Port Talbot County Borough Council's variation request as outlined on pages 3 and 4.

#### **BACKGROUND**

 Variation requests are considered by the Education Investment Panel and recommendations forwarded to the Minister for Education and Welsh Language for consideration.

#### **REQUEST**

# Neath Port Talbot CBC - SOP

- 2. Neath Port Talbot CBC has submitted a variation request with 2 main components:
  - Seek approval in principle for the revised proposal for Swansea Valley;
    and
  - b. Seek approval in principle for two new projects to meet demand for learners with additional learning needs.

# Swansea Valley Revised Proposal

- 3. The Ysgol Newydd Swansea Valley proposal involved the amalgamation of three English medium primary schools in the Swansea Valley, which included Godre'rgraig, Alltwen and Llangwig. The proposal would have resulted in a new 630 place primary school building being constructed with a 25m swimming pool for learner and community use.
- 4. The FBC for the project was previously approved subject to a satisfactory Welsh Language Impact Assessment (WLIA) being approved by the Welsh Government.
- 5. The statutory consultation on the proposal was highly controversial and was subject to a successful Judicial Review from RhAG. Following the judgement, the local authority determined to reconsult on the same proposal, which took place earlier this year. Whilst local authority officers recommended that the proposal be approved, the local authority's Cabinet determined to abandon the proposal.
- 6. The local authority has been undertaking a full review of the project since that decision and is now formally requesting we remove the Swansea Valley project from their programme. There will be a small clawback of just over £100k.
- 7. The revised proposal is to progress with a rebuild of just one of the three schools, Godre'rgraig Primary School. The school was temporarily relocated from its existing site due to landslide risk and is currently in temporary accommodation. This proposed new build would provide a 210 place primary school building which would increase capacity by 48 learners with an estimated

- cost of £17m. There are no alternative proposals for the other schools that were included in the original proposal.
- 8. Programme Team and Cymraeg 2050 officials have reviewed the request and do not consider there to be sufficient evidence provided to approve the revised proposal. The main concerns (which were also echoed on the original Swansea Valley Proposal) are around the potential impact on the Welsh Language as a result of increasing English medium provision within the area. There are currently 112 learners on roll at Godre'rgraig so the revised capacity would provide significant scope of expansion. The proposal needs to be considered in the context of the wider primary education provision with the four nearest English medium primary schools having 153 surplus places.
- 9. The variation request was considered by Education Investment Panel, which recommends that the revised proposal is not approved in principle without sight of a full WLIA which considers the wider primary education provision. The Programme Team also note that the proposed project cost is very high for the proposed building size which would need greater justification to demonstrate value for money.

# New projects to meet demand for learners with additional learning needs

- 10. The local authority is also requesting approval to add two additional projects to meet demand for learners with additional learning needs as outlined below.
- 11. **Expansion of Ysgol Maes Y Coed:** Special school for Children with Autistic Spectrum Disorder (ASD) / Social Communication Difficulties in addition to Severe and Profound Multiple Learning Difficulties (SLD/PMLD). Expansion is required to meet growing demand for specialist provision.
- 12. Establish the Skills and Vocational Hub: Providing provision for young people requiring an alternative to the more usual academic route the hub will offer a skills and vocational curriculum. It is proposed to create the hub in the vacant formed Education Learning Resource Service (ELRS) building at Velindre. Learners will remain on roll at their mainstream school but will be able to access the provision as required.
- 13. The two projects form part of the local authority's education strategy to best meet the needs of learners with additional learning needs. Education investment Panel was supportive of the proposed projects and recommend approval in principle, subject to completion of the relevant business cases. The projects will form part of the local authority's rolling programme.
