ATISN 25122 Additional information regarding Godre'r-graig Quarry / Cilmaengwyn tip Information requested

Thank you for your request which I received on 3 September 2025. You asked for:

the date the site (Godre'r-graig Quarry / Cilmaengwyn tip -T37552) was recorded on the
national register and given the classification D, the attribution associated with the tip record
in our data, as referred to in our previous response (ATISN 25033), and all records of this
attribution and or background data including any correspondence.

Our response

In my response to ATISN 25033 I stated Godre'r-graig Quarry / Cilmaengwyn tip -T37552 was first published as part of the launch of the publicly available National Disused Coal Tips Dataset in November 2023. Up until this point, 'the register', to which I assume you mean the National Disused Coal Tips Dataset, was a working copy which was still being collated and finalised ready to be published.

I have provided in Annex A information included in geographic datasets attributed to the 'geometry' (the boundary) of T37522. This is the attribution referred to the response to ATISN 25033. Some of these versions of the data predate the publication of the finalised version in November 2023.

The attribution shows that the tip had a classification of category D prior to its inclusion in the National Dataset in November 2023.

There is no associated correspondence with the attribution provided.

Next steps

Annex A: Attribution assigned to the Godre'r-graig Quarry / Cilmaengwyn tip – UID: T37552

The following details the attribution associated with the geospatial boundary captured for Godre'r-graig Quarry / Cilmaengwyn tip. The attribution and structure is not absolutely consistent over time; it changes as the data evolves and progresses towards a more stable and complete state at the time of its initial publication in November 2023.

1. December 2021 - Geometry in Welsh Government Non-Coal tips Data Layer. This is a working dataset that contains information for tips considered to be comprised of non coal material. It is not definitive but a part of the assessment and collation exercise that informed the National Disused Coal Tips Dataset.
